## **Director Message**



Pakistan is a disaster-prone country located in a High Risk Seismic Zone and rated amongst the top ten countries affected by phenomena arising from climate change. Uncontrolled population growth, mass urbanization and the threat of terrorism have also made Pakistan equally vulnerable to man-made disasters. Natural calamities and man-made disasters take a heavy toll on schools in Pakistan resulting in many child casualties. The destruction of approximately 7,489 schools during the 2005 earthquake and more than 10,000 schools in the 2010 floods bears testimony to the fact.

The above situation calls for deliberate and vigorous efforts to mitigate the losses as a result of such incidents in future School safety involves a conscious, systematized effort to assess risk from potential natural and man-made hazards to counter those risks. It involves planning and preparing so as to be secure from and able to respond effectively to threats or hazards that may endanger the lives of students, teachers and others and/or disrupt educational continuity (i.e. student's continued learning in a conducive environment during and after a hazard has struck).

The earthquake 2005 has taken 20,000 precious lives of school children and teaching staff. This was a wakeup call for the government of Pakistan to protect the educational system from natural and human induced disasters. Therefore, the National Disaster Management Authority (NDMA) developed Pakistan School Safety Framework (PSSF) with the direction for all provinces to integrate DRR in education system. In this context Elementary and Secondary Department Government of Khyber Pakhtunkhwa established DRR steering committee. In the recommendations of DRR steering committee Directorate of Elementary and Secondary Education Government of Khyber Pakhtunkhwa established School Safety Cell with the Technical and Financial Support of UNICE in 2018.

Since from the inception (2018-2021) school Safety Cell DoE&SE KP has achieved a number of milestones including trainings on Disaster Risk Reduction for senior management officer, education managers, school Head Teachers and PETs, trainings on SOPs for education managers and school head teachers. Trainings on PTC, Mother Group, MHM Health and Hygiene in 80 girls' primary schools of District Kurram and Orakzai. 
### **Executive Summary**

This report is based on progress since the inception (2018-2021) of School Safety Cell -Directorate of Elementary and Secondary Education (SSC-DoE&SE) Government of Khyber Pakhtunkhwa. The School Safety Cell is a provincial platform established with the Technical and Financial support from UNICEF. The report highlighting the progress, events, coordination with stakeholders, advocacy and linkages, impacts, challenge and lesson learnt. During this period, School Safety Cell has successfully accomplished activities in all 35 districts of the province. In spite of all the challenges, in a span of 4-years School Safety Cell accomplished a series of activities including, 1st & 2<sup>nd</sup> Coordination meetings, manual for DRR and ECE, orientation of partners, distribution of Kits, trained 836 senior management officer and Education Managers (Male, 599. Female, 237) on 5-days DRR, ToT for 30 Master Trainers (Male. 15, Female. 15), 1530 (Male. 784 Female. 746) school Head Teachers and PETs on 4-days DRR training. To ensure safe reopening of schools in response to COVID-19 SSC trained online 84 education mangers (Male.44, Female.40) and face to face 589 school heads (Male.304, female. 285) who further trained 98,124 school heads (Male.82,315, Female. 15.807) on approved manual of SOPS from DCTE. In addition to this SSC has accomplished PTC, Capacity Building of Mother Group, Health and Hygiene and Menstrual Hygiene Management and ECE trainings and distributed kits of Safe Health and Hygiene and SIB in 80 GAC funded schools of District Kurram and Orakzai.

Similarly, to sensitize and to promote a culture of safety SSC has celebrated national and international days and events including IDDRR–in 2018, 2019, 2020 and 2021, commemorated the 5<sup>th</sup>,6<sup>th</sup> and 7<sup>th</sup> anniversary of APS Peshawar (Black Day), DRR drawing Competition, Spring Season Plantation 2020 and 2021, World Children's day 2020 and 2021, International Girls child Day 2021, Special Children Day 2021, Mock Drills exercise in all 35 districts of Khyber Pakhtunkhwa. Where 247,079 Students (125693 boys, 121386 girls), 4139 Teachers (Male: 2187, Female: 1952), 1257 PTC members (Male: 631, Female: 626) practically participated in Mock Exercises.

On march 26<sup>th</sup>, 2020 DoE&SE KP notified School Safety Cell as the focal unit to cope with COVID-19 emergency response activities at Directorate. SSC has also disseminated COVID-19 IEC materials to 12'06'011(Male.890083, Female .327733) in different district of province.

School Safety Cell believe on Liaison with actors', stakeholders and developed close working relations with NDMA, NIDM, PDMA KP, Rescue 1122, PRCS, Alkhidmat foundation, health department, DCTE and DPD. School Safety Cell has also developed social sites including dashboard, school safety cell Facebook and WhatsApp pages/groups to share updated and authentic information with school children, teachers and general public. Since the establishment of School Safety Cell, UNICEF has provided Technical and Financial support in each and every activity accomplished in these 4 years span.





### 1. Introduction:

### 1.1 The Context

Pakistan has a rich history of terrible incidents of student casualties during earthquakes, floods and other emergency situations in schools. The 2005 earthquake killed 18,000 children and 900 teachers, destroyed approximately 7,489 schools, the APS terrorist attack killed 149 students and teachers and the century flood 2010, damaged more than 10,000 schools are the evidences to the fact. To respond efficiently and effectively in any future disasters, it is of extreme importance that the workforce and the educational institutions should be properly trained and prepare. In addition to these the school building should be resilience in nature by adopting building codes and preventive measures so that the education institution should cope against any disasters. in order to mainstream DRR into Education to create a culture of safety in the province, adherence provincial, national and international frameworks on hazard identification, preparedness, mitigation and prevention, secretary Elementary & Secondary Education, Khyber Pakhtunkhwa constituted steering committee on December, 2013 for Disaster Risk Reduction (Annexure-A). On March, 2014 for effective working on DRR mainstreaming additional Secretary Elementary & Secondary Education Khyber Pakhtunkhwa has established and finalized sub working groups (Annexure-B).

In the light of DRR Steering Committee the Directorate of Elementary and Secondary Education Khyber Pakhtunkhwa established School Safety Cell on 31<sup>st</sup> August, 2018 with task to implement Emergency Standard Operating Procedure (ESOPs, capacity building on School Safety and DRR for education managers, Head Teachers, development of manuals and coordination with various stakeholders across the province (Annexure-C). On 26<sup>th</sup> march 2020 Directorate E&SE government of Khyber Pakhtunkhwa designated SSC as the focal unit for supporting preparedness and response activities related to COVID-19 (Annexure-D).

### 1.1.2 SSC Vision

- Promotion of DRR in teaching and learning.
- Provision of Safe school environment.
- Promotion of School Safety and Disaster Risk Reduction.

#### 1.1.3 Designed Activities

The School Safety Cell (SSC) performs the following activities to produce the desired results.

- Implementation of Pakistan School Safety Framework.
- Mainstreaming DRR in Education
- Provide a repository for training materials, manuals, and awareness raising on advocacy on School Safety and DRR.
- Capacity Building intervention on School Safety and DRR for Education Managers, Head Teachers and PET.

#### 1.1.4 Thematic Areas / Focus

The School Safety Cell (SSC), is

- Provision of safe school environments which emphasis on safety inspections and assessments of education facilities.
- Enhance coping capacity of in-service teacher on School Safety, DRR, develop supportive materials on school safety, support in school level vulnerability and capacity assessment and early warning system.
- Provincial coordination forum in which all relevant organizations work together to support the E&SED to address school safety under the policy guidance of the Pakistan School Safety Framework (PSSF) and the KP Emergency Standard Operating Procedures (ESOPs),
- To develop linkages between education sector and DM sector as well as public safety policies and plans at each level of social organization.



- To establish communication and coordination linkages across sectors and to Support capacity building initiatives to implement ESOPs at the provincial, district and school levels are also included in the role and responsibilities of School Safety Cell (SSC).
- Provide technical assistance to E&SE for coordination of interventions by all relevant stakeholders on Early Learning, School Safety, Emergency Response, Disaster Risk Reduction, Climate Change Adaptation, Gender responsive programming, strengthening of PTCs and community engagement, with a focus on girls and children with special needs.
- Conduct a study on children with learning disabilities; provide support for teacher training focused on children with learning disabilities.

#### 2. Progress of Activities

Since 31st August, 2018 to 20th December 2021 School Safety Cell (SSC) has successfully accomplished number milestones as fellow.


### 2.1 Distribution at Government Primary School Arandu Gol Valley Chitral

On Sunday, September 13<sup>th</sup>, 2018 at 4:30 am a blast occurred at the Government Primary School in Arandu Gol Valley of Chitral. The school is located in Arandu Gol valley of Chitral district, in close proximity of the Pak-Afghan border. Two rooms of the school were completely damaged in the explosion. However, there were no reports of any loss of life in the incident. An improvised explosive device was used to destroy the only primary school in the area. A police party escaped another IED blast in the area, the police official said. A second IED had been planted along the road near the school and went off minutes after policemen passed by the spot. The Directorate of Elementary and Secondary Education planned a quick response to an urgent need in Chitral with support from UNICEF. Some items were delivered to the damaged school on an urgent basis to ensure continuation of teaching learning process. To supervise distribution of supplies a visit was conducted on 6<sup>th</sup> October, 2018.

#### 2.2 Impacts:

- Installed of Winterized school tents to the affected area.
- Distributed school bags among the students.
- Distributed of recreational and School in box kits among the school in Arandu Valley Chitral.
- ❖ Distributed MRE IEC materials to principle of the affected schools.

#### 3.1 Coordination with Partners/Stakeholder

Keeping in view, SSC as a provincial coordination forum conducted two coordination meetings on September 18<sup>th</sup>, 2018 and January 23rd ,2020 at Pearl continental, Peshawar. Various Partner organizations like NDMA, PDMA KP, CDPM, Civil Defense, Rescue-1122, HOPE'87, HELVETAS, PRCS and SRSP share their multimedia presentations and apprised the contributors regarding their school safety relevant projects, achievements and challenges. The Participants highly appreciated their services and highlighted that now they have a reputed forum available in form of SSC for sharing their experiences & issues and resolving their problems. The SSC shared the progress of assigned tasks during 1st Coordination meeting. In the 2nd Coordination meeting the SSC achievements were highly appreciated and were assigned new tasks i-e Continuity of School Safety Cell (SSC) activities in Newly Merged Districts, SSC should take lead on preparation of district level DRR/School Safety Plan and to monitor

regular mock drill exercises in the schools, children knowledge about DRR, emergency response and use of DRR tool kits.

- The SSC role was highly appreciated and was given new tasks i-e take lead on preparation of district level DRR plans, support Private schools to conduct vulnerability assessment.
- The Project Director Forest department agreed to sing MOU with School Safety Cell regarding awareness among students and tree planation in schools.

#### 4.1 Orientation of Partners

In order to start the first phase of Disaster Risk Reduction trainings for Education Managers School Safety Cell (SSC) Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar has planned 2 days' orientation session for master trainers on the concept of school safety & Disaster Risk Reduction in Government schools of Khyber Pakhtunkhwa held at BISE, Abbottabad on October 27-28, 2018. It was decided, to complete the target of 690 Education Managers in 8 rounds in four centers i-e Peshawar, (Peshawar Division), Abbottabad (Hazard Division), D I Khan (D I Khan Division) and Swat (Malakand Division). The master trainers of PITE and the Public Sector DRR entities Rescue-1122, Civil Defense and Pakistan Red Crescent Society (PRCS) were invited for the session.

#### 5.1 Manual Review

Initially, SSC team collected and thoroughly read manuals on school safety developed by national and international organizations. Later on, the DRR Teacher Training Manual was taken as a base manual, developed by Directorate of E&SE Khyber Pakhtunkhwa in 2017 with the technical support of Provincial Institute of Teacher Education (PITE), Directorate of Curriculum Teacher Education (DCTE), PEACE and Hope 87. This manual was properly reviewed by the technical and Financial support of UNICEF. Two days meeting was held at Abbottabad board participated by partners/stakeholders and endorsed from DCTE which was utilized for 5 days DRR training of Education Managers.

Letter on, to commence the DRR training for Head Teachers and PETs the manual was again reviewed on 5th and 6th July, 2019. The meeting was dignified by the experts from, DCTE, PITE, UNICEF and SSC. The participants put forward fruitful suggestions based in the light of prevailing situation of the province and DCTE incorporated all those changes and officially approved the manual.

### 5.2 Impacts

- The manual is prepared in the light of Pakistan School Safety framework.
- This manual/handbook is designed for trainers and facilitators who work with the school communities to raise awareness about School Safety and DRR.
- The Manual provides guidance to teachers to conduct Risk assessment at school level
- The manual has clearly and simply highlighted the process of school safety Plan and emergency preparedness plan.

### 6.1 Education Managers Trained on DRR

School Safety Cell Directorate of Elementary and Secondary Education (SSC-DoE&SE) government of Khyber Pakhtunkhwa used top to bottom up approach and trained 836 education managers (Male: 599 and Female: 237) on 5-days DRR training of all levels including Additional Directors, Deputy Directors, Assistant Directors, District Education Officers (DEOs), Deputy District Education Officers (DDOs), Sub-divisional Education

Officers (SDEOs), Assistant District Education officers (ADEOs), and Assistant Sub-Divisional Educational Officers (ASDEOs). The 5 –days DRR training for education managers spanned over five months (w.e.f. 26th November 2018 to 26th April 2019) and were conducted in four centers including Peshawar, Abbottabad, D I Khan and Swat in 8 rounds. The training was planned by SSC and executed by PITE with technical and financial assistance from UNICEF. As per agenda the first four days of training covered the theory while on 5th day of the workshop practical demonstration conducted at each venue with the support of partners including Rescue1122, PRCS and Civil Defense.

In order to reduce the disasters risks associated with educational institutions we need to integrate DRR and mitigation measures in all ongoing and future plans of education department. In order to enhance the knowledge of Senior Management of E&SE department and attached Directorates on DRR so that they can monitor DRR activities across the province, SSC-DoE&SE Khyber Pakhtunkhwa has successfully organized 3 days DRR training in two batches i-e 2<sup>nd</sup> -4<sup>th</sup> August, 2019 and 16<sup>th</sup> – 18<sup>th</sup> August, 2019 at Swat Serena for the 48 ( Male: 46, Female:2) Senior Management of E&SE department including Secretary E&SED KP Additional Secretaries, Deputy Secretaries, Director/Deputy ESRU & EMIS, Chief Planning Officer /Sr. Planning Officers, Director PITE, Director DCTE, and officers of Directorate of E&SE KP.

- The E&SED Department equipped to initiate, administer, and evaluate emergency operations programs.
- Learnt how to ensure the coordinated response of all schools within the system.

#### 8.1 Training of the Trainers (TOT)

To conduct DRR training for Head Teachers and PETs efficiently and effectively, training of the trainers (ToT) was organized on 5<sup>th</sup> to 6<sup>th</sup> August, 2019 at Pameer hotel swat. In this ToT a pool of 27 Master Trainers (Male-15, Female-12) of education department from the targeted districts were trained. On August 27<sup>th</sup>, 2019 the trained Master Trainers deployed in groups of 2 or 3 in the targeted districts to conduct DRR training for Head Teachers and PETS.

#### 9.1 Head Teachers & PETs Trained on DRR

In order to respond efficiently and effectively in any emergency situation School Safety Cell (SSC) Directorate of Elementary and Secondary Education Khyber Pakhtunkhwa has successfully trained 1530 (784 males, 746 female) head teachers and PETs on 3 days Disaster Risk Reduction (DRR) training from 1208 Schools in 10 rounds in five districts of KP i-e Swat, Buner, Dir Upper, Dir Lower and Mansehra. The training was formally commenced on 27th August, 2019 and ended on 21st November, 2019. The 3 days DRR training comprised on two days' theory and one-day practical demonstration conducted by our partners PRCS and Rescue 1122.





In 2018 the mega event was held at Government Comprehensive High School Kohat, in 2019 at Government Centennial Model Higher Secondary School Wadudia, Saidu Sharif, Swat. While, in 2020 and 2021 by SSC district focal persons with the technical and financial support from UNICEF in 900 government schools 337 primary schools (Boys :216, Girls: 121), 310 in Middle schools (Boys:180, Girls:130) and 253 in High schools (Boys: 193, Girls:117). Globally the IDDRR is observed to express solidarity with the bereaved families who lost their dear ones, to raise the profile of disaster risk reduction, to aware the community in general and students and teachers in particular regarding importance of the day, to mitigate the risks of natural as well as manmade disasters. 

### 17.1 Spring Season Plantation

Planting more trees is the way to combat the issues of climate changes and the mitigate the consequences of extreme weather events. The plants are playing a crucial role in safe guarding against hydro meteorological phenomena by providing percolation, run off and sediment control. Forests, trees and vegetation cover lessen the harmful effects of erosion, mud flow, landslide, flood and drought. It is now well understood that tress and forests provide a range of benefits to community in the shape of economy, protection from disaster. Forests and trees not only play its active role in DRR but globally it also plays its role in mitigating climate change through carbon confiscation. The event of "Plantation for Pakistan" was jointly organized in 2020 and 2021 by SSC and Khyber Pakhtunkhwa Forest Department in 12 districts of Khyber Pakhtunkhwa. Out of the total

2.5 million plants 374,480 Plants are planted within the schools by school children and Teachers.

### 18.1 Monitoring of Schools trained on DRR

After successful completion of 3 Days DRR training for school Head Teachers/PET's of five districts including Dir (Upper), Dir (Lower), Swat, Buner and Mansehra, with the technical support of Rescue 1122 & PRCS. Based on School Safety Plan a monitoring checklist was developed by School Safety Cell. Before COVID-19 crises two visits were conducted to District Mansehra on 26<sup>th</sup> to 28<sup>th</sup> February 2020, and on 11<sup>th</sup> to 13<sup>th</sup> February,2020. In the light of checklist, it was observed during the visit that all the visited school have formulated School Disaster Management Committees (SDMCs), Hazards and Risk Mapping. The visited schools have conducted awareness session on DRR for teachers and students and have taken measures to lessen the impacts of flood, fire and Earthquake. Similarly, these schools have developed evacuation map displayed in the visible places in school.

#### 19.1 Vulnerable Schools

On March 5th a boundary wall collapsed of Government Primary School (GPS) Notmaira No.2 Tehsil Barikot Swat. As a result, 1 child of class 1st died and 3 more injured. In the light of the primary mandate of SSC i-e provision of safe school environment, promotion of school safety and DRR in all schools of the province, immediately SSC visited the affected school on and find out the causes of the event and shared with DEO swat and Directorate of E&SE KP for further process to minimize the vulnerability.

### 19.2 Vulnerability of School:

Physically the school is constructed on marginalized location having no proper access. Each day the children have to cross the stream to reach school.

In the senior management training it was decided that school safety cell will conduct school profiling of 10 vulnerable districts. In the light of that decision the School Safety Cell (SSC) conducted meeting with District Education Office (DEO) Swat on 13th March, 2020 to discuss the existing exposure and vulnerability of GPS Notmaira No.2 and other vulnerable schools. The DEO office informed the SSC team that due to geographical location of Swat number of schools are vulnerable to both natural and human induced disasters. Similarly, many cases of mud flow, collapse of boundary walls and rooms are reported in the past in different tehsils of district swat. Therefore, the DEO office shared list of 127 vulnerable schools duly verified by Sub Divisional Education Office (SDEO) and Principal/ Head Master. The DEO office stated that these schools were affected by natural hazards in the past and still vulnerable to both natural and anthropogenic hazards.

### 19.3 Suggestion and Recommendation:

Due to the geographical location of district swat, the School Safety Cell (SSC) suggests to conduct proper assessment of all schools. The assessment must be supported both by structure and non- structure mitigation measures. The assessment should be based on multi-sectoral level including engineers, economists, environmentalists, sociologists, Disaster Managers and educationists.

### 20.1 DRR tool Kit distributed

The DRR took Kit distribution was started by School Safety Cell on April, 2020 from District Swat, Buner followed by Mansehra, Dir Upper and Dir Lower. The DRR tool kit is a set of books and CD having stories on precautionary measures of rainfall, Clod weather, earthquake and a brusher on Disaster Risk Reduction measures for flood, weather and displacement. A systematic process was adopted by SSC team to handover the DRR tool kits to those teachers who have attended the DRR training. For this purpose, the SSC team has directly informed the Head Teachers and PETs through calls and messages. Each day the SSC team visited to the targeted districts while following all the precautionary measures of COVID-19. In addition to this the SSC team guided and oriented each teacher on effective use of DRR tool Kit, School Safety Instruction Banner and COVID-19 IEC stuff. The SSC team ensured them to guide the students on DRR tool kit. Likewise, the teachers were also guided to fix and display the Banners in visible places of schools. The SSC team visited the schools and fixed the COVID-19 banners in schools. The distribution of DRR tool kits and School Safety instruction banners are distributed in all 1208 targeted schools while COVID-19 IEC materials are distributed in 147 schools of Dir upper and in 53 girl's schools of Dir Lower. Beside these SSC team also verified the DRR tool kit distributed by SRSP and HIN by visiting schools and also telephonically verified from school teachers.

#### 20.2 Impacts

- Knowledge development in teachers.

#### 22 Orientation on COVID-19 IEC Materials

The COVID-19 IEC materials are designed to aware the teachers, children and parents about Precautionary measures of COVID-19. These IEC materials enhance the knowledge and information how to combat the novel corona virus.

The Head Teachers & PETs were also trained on COVID-19 Precautionary measures including hands washing with soap for 20 minutes, avoid touching eyes, nose and mouth, wear masks if you are coughing or sneezing, avoid close contact and travel, cover mouth and nose with flexed elbow or tissue when coughing sneezing, avoid handshakes and close contact and stay at home. The SSC team oriented the teachers and the teachers further oriented school children.





The Khyber Pakhtunkhwa districts administration has nominated 175 government schools for COVID-19 as quarantine centers. Some of these quarantine centers have facilitated as a quarantine center. The SSC team guided and supported these centers in the light of SOPs for quarantine center.



### 23.3 COVID-19 Learning material contents

The School Safety Cell has also shared the COVID-19 learning content materials with 13078 individual beneficiaries and 1580 schools Head Teachers.

To establish appropriate partnership School safety cell has kept close Liaison with other local and international actors to ensure synergy with other similar initiatives.

#### 24.1.2 Coordination with NDMA, NIDM and NDRMF

On June,27<sup>th</sup> to 28<sup>th</sup> ,2019 School safety Cell organized two days' coordination meeting with National Disaster Management Authority (NDMA), National Institute of Disaster Management (NIDM) and National Disaster Risk Management Fund (NDRMF). During the meeting all the three leading Disaster Management Authorities were briefed on role, responsibilities, activities, progress and milestone achieved by SSC since its inception and agreed on close coordination.

### 26.3 Tier-3: Trainings, events and Distribution:




### 26.4 Tier-4: Events and Distribution:

### 27. World's Children Day

The United Nations' (UN) Universal Children's Day, which was established in 1954, is celebrated globally on 20th November each year to promote children's welfare and awareness among children, parents and general public to realize the rights of children under the convention on the Right of the Child (CRC). World Children's Day marks the adoption of the Convention on 20th November1989. Pakistan ratified the Convention the following year. ## 32. Enrollment Campaign 2021

Education Department is the biggest of all departments of Khyber Pakhtunkhwa, it has more than 1,68,000 employees which are about 55% of the total employees of the province, 3.9 million students are learning in more than 28000 Government Institutions including primary, middle, high and higher secondary schools having more than 1,19,000 teachers. According to economic survey of Pakistan 2019 -2020 the class enrollment ratio is 80 in Pre- primary 96% in Primary, 45% secondary. According to Khyber Pakhtunkhwa Education Sector Programme (KESP) there are 2.6m out-of-school children (67% are girls) in the province of Khyber Pakhtunkhwa (KP). Half of KP's population are illiterate (disproportionately women) and most drop-out prior to reaching middle and secondary levels. According to ASER 2019, 67% boys and 33% girls are enrolled in government schools while 64% boys and 36% girls are enrolled in private schools in Khyber Pakhtunkhwa.

2021 SSC-DoE & SE government of Khyber Pakhtunkhwa under the project Title" Improved access to Quality Education for Girls is merged Districts of Khyber Pakhtunkhwa" with the Technical and Financial Support of Global Affair Canada Kicked off enrollment Campaign ceremony in 04 targeted schools of District Kurram and Orakzai i-e (02 each Kurram & Orakzai, GGPS No.1 Parachinar & GGPS Bagan: GGPS Andkhel & GGPS Mirbak). The events were graced by District Education Officers (Male/Female), Parent Teachers Council (PTC), Mother Groups and School Head Teachers of 80 GAC targeted schools and SSC team. The children warmly presented speeches, naghmas, melodies and drams. Prizes were distributed among all the children who participated in the program. Lunch Boxes were given to all kids as they were the guests of the day. At the end awareness walks was headed by District Education Officer in the presence of PTC, Mother Groups, children, following the SOPs in the face of COVID-19. The Enrolment Campaign activities were also organized in all 80 GAC targeted schools of District Kurram & District Orakzai (40 Each District).

#### 34.1 Dyslexia:

Dyslexia is a language-based learning disability. Dyslexia refers to a cluster of symptoms, which result in people having difficulties with specific language skills, particularly reading. Students with Dyslexia usually experience difficulties with other language skills such as spelling, writing, and pronouncing words. Dyslexia affects individuals throughout their lives; however, its impact can change at different stages in a person's life. In Pakistan's context, this area of research is comparatively less explored which could be due to poor understanding of chronicity of under investigation phenomenon and lack of students' counseling and formal assessment services for screening of these learning disabilities. The current estimated prevalence of Dyslexia in Pakistani students is 40 % which is comparatively higher than in already estimated prevalence of 2% to 15 in south Asian study (e.g., India, 2011) and 2% to 17% in global general prevalence due to lack of knowledge and on time diagnosis. This paucity of research enforces need of structured and well-equipped psychological services to cater need of identification and management of these symptoms on time to reduce future risk and vulnerability (Farzana & Najma, 2020)

SSC-DoE&SE government of Khyber Pakhtunkhwa is conducting this study with the Technical and Financial support of UNICEF in district Peshawar. In this regard meetings in 24 circles (12 male and 12 female) are completed and covered 300 schools

(150 male and 150 female). Likewise, 606 teachers are trained on Dyslexia and distributed 50,000 questionnaires in the targeted schools.

### 34.2 Objectives:

- To identify the learning and behavioral needs of students
- To train the teachers to enhance the learning of the students which will help the students to overcome his/her learning and emotional difficulties.
- To identify children with dyslexia.
- To develop teacher's training manual on Dyslexia
- To enhance the capacity of teachers to conduct classroom-based interventions including to improve reading skills, and to develop achievable, cognitive, and academic goals for all students.

#### 35.1 Mock Drills Exercise

A Mock Drill is the testing of the efficacy of Disaster Management Plan. It is a participatory method to practice the safety related measures and evacuation of the building during emergency situation. It enhances the ability to respond faster, better and in an organized manner during the response phase.

The SSC-DoE&SE government of Khyber Pakhtunkhwa has undertaken the program of institutionalizing School Safety, DRR measures and improving the resilience in schools



of Khyber Pakhtunkhwa with the Technical and Financial support from UNICEF since 2017 with the aim to increase the preparedness of education system to cope with any emergency situation from top to the bottom level and level of education managers, school teachers and students throughout the schools in the province.


Children in schools are the most vulnerable during disasters. A safe and secure environment is a prerequisite for any school, where ensuring safety of children, teachers and supporting staff during disasters is of outmost necessary. Thus, to ensure safety of children in disasters and also to promote faster rehabilitation in post disaster, School Safety Cell Directorate of Elementary and Secondary Education (SSC- DoE &SE) Government Khyber Pakhtunkhwa with the Technical and Financial support from UNICEF has developed a School Safety Mock Drills capsule within its ambit measures like awareness generation, ensuring communication, school Emergency Preparedness plans, Evacuation Plans, capacity building of students and teachers on First Aid, rehearsals and Mock Drills etc is .


The Mock Drills Exercise were conducted in 420 vulnerable schools from all 35 districts of the province. 
